Module 1: Foundations of ERP & Environmental Compliance

- Defining the intersection of ERP, EHS, and Environmental Regulations

- Data structure and master data requirements for environmental metrics in an ERP

- Integrating GIS and Location Data within ERP for site-specific compliance.
- Case Study: A global chemicals manufacturer utilized their ERP's Material Master Data to tag substances with regional regulatory flags, reducing non-compliance risk during cross-border shipping by 25%.

Module 2: End-to-End Traceability & Product Compliance

- Validation of Component Compliance against the Bill of Materials in ERP.
- Case Study: An electronics firm used their ERP to trace a non-compliant component back through four tiers of the supply chain in under 2 hours, avoiding a major market withdrawal penalty.

Module 3: Waste, Water, and Air Emissions Management

- Setting up Waste Stream classification and segregation in the ERP Inventory Management module.
- Automating Waste Manifesting and Regulatory Reporting from the ERP.
- Tracking Water Use and Effluent Discharge data via ERP-integrated utility meters and IoT.
- Calculating and monitoring Air Emissions and permit limits within ERP EHS modules.
- Configuring Non-Conformance workflows for environmental incidents.
- Case Study: A pharmaceutical plant used real-time ERP data integration to identify a leak in a water-intensive process, achieving a 15% reduction in water consumption within one quarter.

Module 4: Energy Management and Carbon Accounting

- ERP configurations for tracking Energy Consumption by cost center, equipment, and production batch.
- Automated calculation of Scope 1 & 2 Greenhouse Gas Emissions using ERP utility data and conversion factors.
- Using ERP to collect and estimate Scope 3 Emissions data
- Developing Energy Reduction Programs and monitoring KPIs against ERP baseline data.
- Integrating Renewable Energy Credits and Carbon Offsets into the financial ledger.
- Case Study: A manufacturing group used their ERP's financial and production data to generate a compliant Scope 1 & 2 GHG report in one day, cutting a process that previously took three weeks of manual work.

Module 5: Supplier & Third-Party Environmental Risk

- Establishing Environmental Due Diligence and Audit Trails for all suppliers in the ERP.
- Managing Supplier Environmental Scorecards and performance tracking in the Procurement module.
- Implementing "Green Procurement" policies and enforcing material restrictions via ERP requisitions.
- Using Blockchain or secure ledgers for unchangeable records of supplier compliance declarations.
- Integrating third-party Sustainability Rating data into the ERP vendor master record.
- Case Study: A fashion retailer mandated all Tier 1 suppliers to upload their water-usage certificates into a shared ERP portal, drastically improving the accuracy of their supply chain ESG data.

Module 6: Audits, Risk Management, and Incident Response

- Using the ERP Audit Management module to schedule, plan, and execute internal/external environmental audits.
- Mapping environmental risks to business processes in the ERP for Proactive Risk Assessment.
- Configuring the ERP for Environmental Incident Reporting and root cause analysis.
- Establishing Corrective and Preventive Actions workflows within the ERP EHS module.
- Generating Auditable Compliance Records and Digital Signatures in the ERP.
- Case Study: An oil and gas company's ERP alerted a site manager to a potential permit breach based on trending emission data, enabling a preventive shutdown and avoiding a \$500,000 fine.

Module 7: Sustainability Reporting and Data Governance

- Customizing ERP reports to align with international standards
- Building Interactive Environmental Dashboards for leadership using ERP Business Intelligence (BI) tools.
- Implementing Data Governance policies for environmental data quality and validation.
- Strategies for managing Non-Financial Data alongside financial data in the ERP.
- Communicating Environmental Performance to external stakeholders using secure ERP data extracts.
- Case Study: A consumer goods company streamlined its annual GRI reporting process from months to weeks by centralizing all relevant environmental data within a single ERP platform.

Module 8: Future Trends: IoT, AI, and Digital Twins

- Integrating Internet of Things (IoT) sensors and devices with ERP for automated data capture.
- Leveraging Artificial Intelligence (AI) and Machine Learning (ML) for predictive compliance analysis in ERP.
